Project title: Shared mobility services towards equitable and sustainable mobilities

Funding institution: National Centre for Research and Development (NCBiR) under the *Driving Urban Transitions* programme

Expected employment period: October 2025 – December 2027

Requirements:

- doctoral student status in the field of social sciences
- availability to work on the project throughout its duration
- excellent command of Polish
- high proficiency in English, enabling fluent communication as well as reading and writing academic texts and presenting results at national and international forums
- qualifications and experience in designing and conducting qualitative research and facilitating workshops with diverse stakeholders
- readiness and willingness to learn
- interest in the project topic
- ability to think logically and synthesise knowledge
- communicativeness

Desirable:

experience in research projects and academic work related to mobility and/or social justice; knowledge of qualitative data analysis software; authorship or co-authorship of articles in academic journals.

Responsibilities:

- Co-creating a justice-oriented toolkit for evaluating mobility policies in a multi-stage, iterative process involving various stakeholders, primarily by contributing to the following tasks:
 - literature review
 - identifying the skills, tools, practices and expectations of local stakeholders in developing and evaluating mobility policies and shared mobility services, using an internal survey, in-depth interviews, and analysis of documents, procedures and data employed by stakeholders

- synthesising knowledge from the above process and the literature review with a focus on practical application
 - developing the toolkit and jointly testing it during workshops
 - generating research data to fill gaps and overcome barriers identified in the previous step using appropriate methods and techniques – qualitative research, surveys, content analysis and/or GIS analyses
 - refining and testing the improved toolkit
 - participation in local and international team meetings
 - co-authoring a scientific article for an international journal
- Participation in local and international team meetings
 - Co-authorship of a scientific article for an international journal

The main part of the work consists of co-organising and co-facilitating workshops, conducting part of the qualitative research – in-depth interviews and research walks – and contributing to the development and dissemination of their results.

Place of work:

Workshops and research are carried out in the Poznań agglomeration and the Upper Silesia–Zagłębie metropolitan area (GZM). Other responsibilities are usually performed remotely.

Project description

The Share4Equity project is funded by the National Centre for Research and Development (NCBR) under the *Driving Urban Transitions* programme, which is co-funded by the European Commission. The project is conducted between January 2025 to December 2027. Its main objectives are:

- to determine the supply of and access to different types of shared mobility in selected European cities and the factors influencing this supply and access
- to better understand the perspectives of people using and not using market-based and informal forms of shared mobility and other modes of transport, in particular which means and places they perceive and experience as accessible or inaccessible to them, and why
- to develop a toolkit for conceptual, quantitative and qualitative analysis of the local mobility system and the current and potential role of shared mobility within local mobility systems in terms of different types and criteria of justice

The project is co-created by institutions from five countries (Germany, Sweden, Italy, Poland, Canada). In addition to research institutions, metropolitan associations, city councils and shared mobility operators are involved. Transnational cooperation makes it possible to compare different aspects of shared mobility in different countries and cities, as well as to share results and test developed tools in diverse cultural, legal and political contexts.

Participation in the project will provide opportunities to develop research and organisational skills, gain international experience, and strengthen academic achievements. It will also serve as a good starting point for further careers in academia, public administration, or the mobility and transport sector.
